Thank you for considering Campo & Poole Distributing and CFN-Fleetwide Card fueling System. Below is a list of pertinent information about our network:

- 1) All sites are open 24 hours a day.
- 2) All Sites are self-serve.
- 3) The billing period is bimonthly. The 1st thru the 15th of the month is the first billing period.
- 4) The 16th thru the end of the calendar month is the second billing period.
- 5) All invoices are due in full 10 days from the statement date.
- 6) Cardlock volume discounts are available to those paying within the 10 days from statement date. Discount date will be listed on qualifying invoices. **FULL PAYMENT MUST BE RECEIVED IN OUR OFFICE AS NOTED ABOVE TO QUALIFY FOR ANY DISCOUNT:**
- 7) Volume discounts per billing period:
 - 100 - 249 gallons = 1 cent per gallon
 - 250 - 499 gallons = 2 cents per gallon
 - 499 - 749 gallons = 3 cents per gallon
 - Over 749 gallons = 4 cents per gallon

CARDLOCK OPERATING INSTRUCTIONS

(Instructions valid only at CFN SITES)

- 1) Insert your Campo & Poole Distributing card into the CFN Card Reader.
- 2) Enter pump number and press Enter.
- 3) Enter Personal Identification Number (PIN/DID/Fleet PIN) and press Enter.
- 4) If applicable, enter odometer reading and press Enter.
- 5) If applicable, enter vehicle number and press Enter.
- 6) Insert nozzle into vehicle tank and lift pump lever to activate pump.
- 7) Activate nozzle trigger.
- 8) Remove nozzle from vehicle tank when finished fueling.
- 9) Hang nozzle back pump.
- 10) If you want a receipt, re-insert your card into the reader after fueling.







Fuelman Mobile Locator

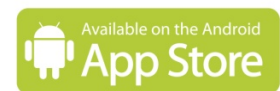
